I. STATE OF THE SCHOOL

• Enrollment

The demographics were reported on the attached demographics sheet. Data was reported as follows: 384 students enrolled; 43 SPED students; 75% of our students are economically disadvantaged; 33% are Hispanic/Latino; 64% are African American. It was further noted that 10% of our population is from out of district and 90% are from Plainfield.

• Report of School Lottery

The lottery report was given, indicating that it was held on April 18, 2018 in UMES-DEL. There were 18 parents and as many children in attendance. A lottery was held for Kindergarten, Grades 1,3,4,5,6,7,8 and 9. Seats not filled at the lottery will be added to the waitlist. The process and procedures are in the Lottery report. • Enrollment Projection

Enrollment projection was discussed informing the Board that we have projected enrollment of 400 students. K-2 cluster, 120 students; 3-5 cluster, 120 students; 6-8 cluster, 120 students; and 9-12 cluster, 160 students. (Report attached).

1. Modification of Resolution of 03/15/2018 for Charter Renewal Services
